

## **ALTEA GREEN POWER: AUTHORIZATION PROCESS INITIATED FOR 1.4 GW OF BESS STORAGE PROJECTS**

Rivoli (Turin), 26 March 2025 – **Altea Green Power (AGP.MI, hereinafter "AGP" or "the Company")**, a company engaged in the development of projects and the construction of "green energy" plants, announces the initiation of the authorization process for BESS Storage projects with an equivalent power capacity of approximately 1.4 GW, expected to reach 2 GW by the end of the current semester.

As of today, the Company has a pipeline of BESS Storage projects amounting to approximately 3.5 GW of power, with an estimated value of at least €150 million and an expected margin in line with the figures presented in the 2024-2028 business plan. These add to the already signed contracts totaling 1.6 GW, of which 460 MW have been authorized.

The decision to proceed with the gradual authorization of projects reflects the Company's commitment to offering its clients a higher level of service and ensuring the opportunity to participate in Terna's auctions, which will take place from this year until 2028. This aspect is of particular interest and relevance for all Altea Green Power stakeholders and investors.

**Giovanni Di Pascale, CEO of Altea Green Power, commented:** *"The launch of this new authorization process for BESS Storage projects represents another key step in Altea Green Power's growth strategy. With a project pipeline reaching 3.5 GW and an estimated value of at least €150 million, we are building a solid and promising portfolio. We are fully committed to the realization of these projects—we have been pioneers in this field, and today more than ever, we are aware of their value for our business and for the energy system.
