



## ALTEA GREEN POWER: ENVIRONMENTAL IMPACT ASSESSMENT APPROVED FOR APPROXIMATELY 50 MW WIND FARM IN BASILICATA

# A SIGNIFICANT STEP IN THE DEVELOPMENT OF WIND FARMS, PART OF THE COMPANY'S OWN PROJECT PIPELINE AS AN INDEPENDENT POWER PRODUCER (IPP)

Rivoli (Turin), 15 April 2025 – **Altea Green Power (AGP.MI, hereinafter "AGP" or "the Company")**, a company engaged in the development of projects and the construction of "green energy" plants, announces that it has obtained the go-ahead for the EIA (Environmental Impact Assessment) application for the construction of an approximately 50 MW wind farm in Basilicata. The plant will be built with 11 turbines, each with a capacity of 4.5 MW.

This wind farm is part of the project pipeline that the company intends to develop within the strategy outlined in the 2024-2028 Business Plan, which includes the construction of owned plants in Italy, as an Independent Power Producer (IPP).

In terms of the stated medium-term objectives, Altea Green Power is progressing ahead of schedule, having already identified projects for over 150 MW, some of which are in an advanced authorisation phase.

Giovanni Di Pascale, CEO of Altea Green Power, commented: "Obtaining environmental approval for this wind farm in Basilicata represents a significant milestone in Altea Green Power's growth journey. We are implementing our industrial strategy, focusing on owned plants and the vertical integration of the supply chain. We are proud to contribute to the country's energy transition with sustainable, innovative projects, including in the wind sector. It is estimated, in fact, that by 2040, energy production from this type of plant will triple, exceeding 40 GW".
